1. The balances appearing in the Balance sheet are as certified by management as external evidence is available to cross verify for the same is unavailable.


3. We report that in our opinion and to the best of our information and according to the explanations given to us the said accounts read with significant accounting policies and other notes thereon give a true and fair view :-
